

Simple Steps to build your Simplexity Health Business

The following steps are for Independent Business Associates (IBAs) who want to *only* sign up product consumers:

1- Make sure that you personally signed up for the \$100 monthly AutoShip in order to receive your check without interruption.

WHY: With an AutoShip, you qualify for all the available bonuses and commissions.

2- Your goal is a group volume* above \$1000 in monthly retail sales.

WHY: You receive maximum commissions on consumers at this stage.

*This “retail sales” volume is your Personal Retail Value, PRV, and consists of the total volume from your personal orders; plus orders from your Preferred Customers; plus any retail sales through the website or company.

The following steps are for Independent Business Associates who want to sign up product consumers *and* recruit new IBAs:

1. Sign up for a monthly \$100* AutoShip

WHY: With an AutoShip you secure your monthly check and qualify for all the available bonuses and commissions.

2. Within any one full calendar month**:

a. Find 2 front line Independent Business Associates (IBAs) who will commit to \$100* monthly AutoShip.

b. Help them each sign up one IBA on their first level.

WHY: You qualify for your first share in the Business Builder’s Pool.

*\$100 Bonus Value—currently, wholesale price

**IF you sign up a IBA in the middle of one month, you will have to end of the full month following to achieve these goals.

3. You and each of your IBAs find 2 consumers to commit to an AutoShip.

WHY: You each obtain the \$300 volume requirement to be an active leg.

Long term goal: Find six front line business associates to work with them to build and expand your network. This might take you one year or five years. It doesn’t matter. Just focus on finding six strong motivated business associates.

4- Along with finding business associates, continue to sign up consumers in your front line.

WHY: By finding consumers as well as BAs, you grow the volume necessary to get maximum payout on your first level.

Long Term Volume Goal: Make sure that your volume and that of your Senior Managers’ volume exceeds a \$1000 personal consumer volume every month.

SUMMARY

For all IBAs interested in sharing product, follow Product building steps.

WHY: To get paid the highest commissions on first level customers.

For your IBAs who want to build the *business*, follow Business steps 1-3.

WHY: This is a very simple duplicatable system that builds volume and allows each IBA to get at least one share in the Business Building Pool as well as qualify for all commissions.

SIGNING UP BAs

Option One

Sign up with a one time purchase of an IBA business kit (\$40)

You are not required to purchase product with this option

Option Two

Place a “Quick Start” order. This costs \$300*.

Advantages of the Fast Start option:

1. Your business kit is included in this purchase.
2. You bypass the \$1000 accumulated GV requirement and are eligible for the Enroller Bonuses, immediately.
3. Your \$300 counts towards the \$500 needed to get Enhanced Retail commission during your first month.

You can either buy one of the two special “Quick Start packages”, which are company specials that offer over \$400 worth of product for \$300, plus the IBA kit; or, you can customize the products to create an order that totals at least \$300, and get the kit for free.

The extra products offer you the benefit of accelerating your experience and knowledge of the SH products to give you greater confidence and credibility in promoting the products. You can eat the extra products; retail them to prospects; or use them as samples to hand to prospects; or all three.

Starting your new business associates with the fast track startup kit of \$300 for their first month, followed by an ongoing monthly auto ship order of \$100 will maximize your income greatly.

*\$300 Bonus Value; currently, wholesale prices

These are the only steps you need to work with and teach your new business associates to do the same and see how healthy and lucrative your network will be.

ONLY DURING THE TRANSITION PERIOD:

(This is the time frame from now until the new plan goes into effect)

We have a small window of opportunity to really promote business building for our BAs who are looking for a reason to get going!

YOU WILL EARN THE 35%/15% ENROLLER BONUS

This is paid on 100% of the commission, which means that every person who gets the \$1500 in *bonusable* volume (\$1875 in product total) that is required to get to executive, **will be earning \$656.25 in commissions! WOW!**

PLUS---IN ADDITION TO THIS--!!!!---And only until the new plan is in effect!

They will ALSO still earn the executive bonuses!

This is at least an additional \$300!

IF they go from a PC or a new sign up status, to Executive, they will earn a total of an additional \$405!

The Breakdown:

\$1875 total Group volume **\$656**
(Product total volume X 80% = \$1500 bonus volume)

PLUS executive cash incentives:

They went executive within 30 days of signing up: **\$405**

Or

They went executive in a longer time span **\$300**

TOTAL COMPENSATION

Executive within 30 days of signing up **\$1061**

Or

Executive in a longer time span **\$956**

The sponsor earns **\$381**

This makes a TOTAL compensation, for achieving executive NOW, of at least \$956--and up to a possible \$1061!!!

There will NEVER BE AN OPPORTUNITY like this one again!

FIRST MONTH PAYOUT:

You get 2 BAs who each find 1 BA. They all go for the Quick Start \$300 order. They each go on a \$100 AShip.

Enroller first order bonus:

1st level: 2 x \$105 = \$210

2nd level: 2 x \$45 = \$90

Total: \$300 PLUS 1 share in the Business Builder's pool

You will earn this much every month you find 2 BAs, who each sign up 1 BA. You can sign up a BA under them and earn the same income as if they were signed up on your first level!

By also finding consumers, you maximize your first level consumer bonus payout.
